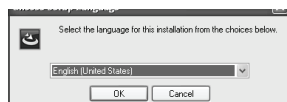


HandyShare Ver.2 Installation Guide

Windows Installation

- 1 Double-click "HandyShare 2.x.x.x Setup.exe" on the included SD card to launch the installer.
 - If you have downloaded the software, the installer is inside the folder that appears after the ZIP file is decompressed.
 - The "2.x.x.x" number indicates the version.

- 2 Select the setup language and click "OK".



- 3 The installation wizard starts. Click "Next" to start the installation process.

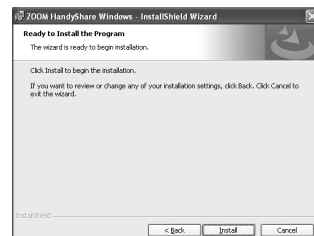


- 4 Carefully read the Software License Agreement that is shown, click the "I accept the terms in the license agreement" button and then click "Next".

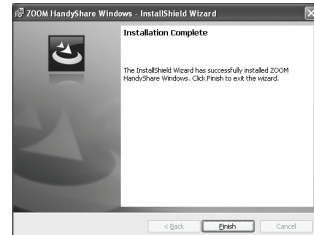


- 5 Select the folder where you want to install. Click "Change" if you want to install the software in a folder other than the standard folder.

- 6 Click "Install" to install the software.



- 7 Click "Finish" to complete the installation.



- When you connect the Q3/Q3HD recorder to your computer, HandyShare will automatically launch.

If QuickTime has not been installed on your computer, or the version installed is an older version, the QuickTime installer will launch. After installing QuickTime, HandyShare will automatically launch when you reconnect the Q3/Q3HD recorder to your computer.

- If you are using HandyShare Ver. 1

On your computer running Windows XP, the first time HandyShare Ver. 2 is automatically launched after it has been installed, a "Start HandyShare" item appears in the auto play dialog. Do not select this. The "Start HandyShare" item will not appear in the auto play dialog when launching automatically after the first time.

Operating requirements

Windows XP (SP2 or later)(32-bit), Windows Vista (SP1 or later) (32/64-bit), Windows 7 (32/64-bit)

- 512 MB RAM (1GB or more recommended)
- 1024x600 or greater screen resolution
- USB 1.1 or 2.0 compatible port

Mac OS X 10.4.6 or later, 10.5, 10.6

- Intel Core Duo 1.66 GHz or faster (Intel Mac required)
- 512 MB RAM (1GB or more recommended)
- 1024x600 or greater screen resolution
- USB 1.1 or 2.0 compatible port

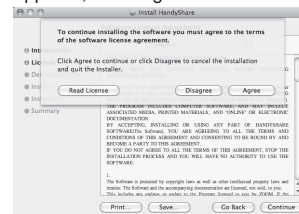

Mac OS X Installation

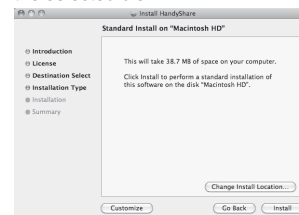
- 1 Double-click "HandyShare 2.x.x.x Setup.mpkg" on the included SD card to launch the installer.
 - If you have downloaded the software, the installer is inside the folder that appears after the ZIP file is decompressed.
 - The "2.x.x.x" number indicates the version.

- 2 The installer starts and the Introduction page is shown. Click "Continue".

- 3 Carefully read the Software License Agreement that is shown, and then press "Continue". When the confirmation dialog appears, click "Agree".



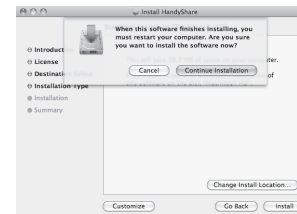
- 4 The Destination Select screen opens. Click "Install" to start installation of the software on the selected disk.



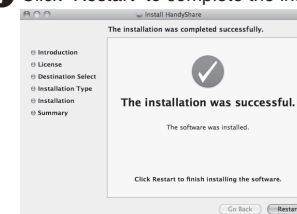
- 5 The password input screen opens. Input the name and password of a user with administrator privileges and click "OK".



- 6 When you click "OK" a dialog confirming that you want to install the software and restart your Mac appears. Click "Continue Installation" to conduct the installation.



- 7 Click "Restart" to complete the installation.



- When you connect the Q3/Q3HD recorder to your Mac, HandyShare will automatically launch.

Important notes about installation

- During installation, administrator privileges are necessary. If you do not have administrator privileges, please consult with your system administrator.
- When installing, quit all other running applications.
- Restarting the computer might be necessary after installation is completed.
